**Numis Corporation Plc (“Numis”)**

The Board of Numis announces that, today, it approved the issue and allotment of 145,000 (0.75%) new ordinary shares in Numis to the Numis Employee Share Trust (“the Trust”) at an average price of 207p per ordinary share.

This follows the surrender of options over 145,000 ordinary shares in Numis under the Numis Unapproved Executive Share Option Scheme and the grant of options over 145,000 ordinary shares in Numis held by the Trust on the same terms, as follow:
